

### MINIMUM REQUIREMENTS FOR RECEIVING THE EBMV2 CLIENT SOFTWARE- (Technical part)

All VAT – registered taxpayers must satisfy the following conditions to receive EBMV.2.0 Software:

#### **Note:** The EBMV2 software is supplied, trained and installed free of charge by RRA.

1. Have a stable internet connection (to be able to connect to RRA servers)

2. Have a computer or laptop and a printer with the following characteristics:

2.2. Operating System	Microsoft Windows 7, or a later version

2.6. Antivirus	Any licensed, updated antivirus is acceptable	
2.7. Input devices	A keyboard in combination with a mouse (or a touch screen)	
2.8. Minimum screen size	5.5 inches screen or above	
2.9. Connectivity	Any of the following: Wi-Fi Adapter,	
	RJ45 Ethernet Port ( for Local Area Network),	
	SIM Card Slot (for 3G or 4G SIM Card)	
2.10. Ports (minimum)	Ports (minimum) Mandatory USB or SD	
	Optional: Parallel, Serial, HDMI, SIM Slot, RJ45	
2.11. Printer	Any printer (Wirelessly or physically connected to the	
	computer) Necessary for printing EBM invoices	
2.12 For <b>POS printer</b>	The paper should have a width of 80 mm	

## **REQUIEREMENTS FOR RECEIVING EBM V2 – (Administrative part)**

#### 1. TRAINING

Attending the EBM V2 training before receiving EBMV2.0 software (Choose one day between: Monday, Wednesday and Thursday from **08:00am** to **12:00pm**)

#### 2. FILLING ONLINE FORM

#### 3. ADMINISTRATIVE DOCUMENTS REQUIRED

A taxpayer should provide the following documents before EBMV2 installation and must come with a computer/laptop which contains windows operating systems.

### If you are the owner/ shareholder of the company, bring:

- A copy of RDB Full Registration Certificate;
- A copy of VAT Certificate;
- ➢ A copy of national ID or passport.

### If you are not owner of the company, bring:

- "Procuration" letter/ letter of representation(Powers of attorney) (Containing Names and ID number of the representative)
- A copy of RDB Full Registration Certificate;
- A copy of VAT Certificate;
- > Copies of national ID or passport (Owner of the company and representative)
