Mu Mujyi wa Kigali, ubufasha buzatangirwa: **(1) i Masaka** ahasanzwe hakorera serivisi z'ibinyabiziga, **(2) Gikondo** ahabera Expo, **(3) Canal Olympia**, **(4) i Nyamirambo** kuri tapis. Mu ntara ubufasha buzatangirwa ku biro bya RRA mu gihugu hose.

- Ubufasha buzajya butangwa kuva kuva Mbere kugeza kuwa Gatandatu.
- Abagomba guhabwa serivisi bazajya bahabwa gahunda mu butumwa bugufi kuri telefoni bandikishije basaba serivisi.
- Abari baramaze gusaba mutation bataragerwaho bazahabwa gahunda(rendez-vous) nshya.
- Abatari bagasabye mutation bahita basaba kugira ngo bafashwe muri iki gihe kidasanzwe.
- Abacyanditsweho ibinyabiziga byavuye mu muhanda barasabwa kubiyandukuzaho no gusubiza ibirango byabyo (plaques na carte jaune).

Special Support on Motor Vehicle Ownership Transfer and De-registration


Rwanda Revenue Authority (RRA), in partnership with Rwanda National Police (RNP), informs the public that **special service support shall be offered to everyone who purchased or sold a motor vehicle but have not transferred ownership, as well as those whose motor vehicles have reached end-of-life but have not been de-registered them.** This special service support shall be offered from **Tuesday, 26 January to 28 February 2026.**

In the City of Kigali, special service support shall be provided at the following locations: **(1) Masaka** Office of Motor Vehicle Services, **(2) Gikondo Expo Grounds**, **(3) Canal Olympia**, and **(4) Nyamirambo**, near Pele Stadium. In the provinces, the service shall be offered at RRA Tax Centers.

- Motor vehicle service support shall be provided from Monday to Saturday.
- Appointments shall be communicated via SMS to those who have requested the service.
- Clients who had already requested the service shall be given new, earlier appointments.
- Those who have not yet requested ownership transfer are encouraged to request the service during this special support period.
- Owners whose motor vehicles have reached end-of-life are requested to de-register them and return the number plates and logbooks.
