4. Inyandiko ya banki igaragaza uko konti ihagaze (niba muyifite)

ANNOUNCEMENT ON TIN DE-REGISTRATION

Rwanda Revenue Authority calls for **all persons (individual, company, governmental and non-governmental organizations) with Tax Identification Numbers (TIN) who are no longer in operation or who have never operated to officially and voluntarily request for de-registration of their TIN by 15th January 2023.**

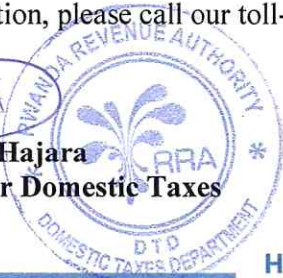
Interested taxpayers are required to do the following:

1. Get a recommendation from the Sector Office confirming non-operational status
2. Complete Online de-registration request using e-tax system
3. Use pre-filled de-registration form available at <https://www.rra.gov.rw/en/domestic-tax-services/registration-de-registration>
4. Provide bank statement (if opened one for that very TIN)

Note: Taxpayers who applied manually are required to resend their application through: <https://etax.rra.gov.rw/> where you will enter your TIN and Password, then choose online request and de-registration request.
