ANNOUNCEMENT

Applications for Customs Duty Remission

Pursuant to Article 140 of the East African Community Customs Management Act, 2004 (EAC CMA 2004) and considering that the Council, through notices in the Gazette, may determine from time to time the use of imported materials in the manufacture of approved goods for domestic consumption;

Rwanda Revenue Authority (RRA) informs all manufacturers who wish to apply for duty remission for the Financial Year 2024/2025 (July 2024-June 2025) that the deadline for submitting applications is 15th April 2024. Applications will be sent to: dutyremission@rra.gov.rw

The following requirements must be met to qualify for Duty Remission

- 1. The application shall be addressed to the Commissioner for Customs using Form R1;
- 2. Applicants must provide the Business registration certificate issued by RDB;
- 3. Applicants must provide their production formula;
- 4. Applicants must have EBM V2 that received the latest updates;
- 5. Applicants who are under real regime on income tax, must provide Quitus fiscal. Those in lump sum and flat regime shall provide Tax clearance certificate;
- 6. Applicants requesting for renewal must submit the stock of the remaining raw materials from previous imports and the stock of unsold products at the time of application,
- 7. Applicants whose previous duty remission was revoked are not allowed to apply.
