### THE EAST AFRICAN COMMUNITY CUSTOMS MANAGEMENT ACT, 2004

NOTIFICATION OF INTENDED DISPOSSAL OF OVERSTAYED GOODS AT INLAND CONTAINER DEPOT (ICD) NAIROBI BY THE COMMISSIONER CUSTOMS & BORDER CONTROL, KENYA REVENUE AUTHORITY

(Pursuant to Section 42(1) of the East African Community Customs Management Act 2004)

#### **LEGAL NOTICE**

IN EXERCISE of the powers conferred under Section 42(1) of the East African Community Customs Management Act, 2004 (as amended), notice is hereby given by the Commissioner Customs & Border Control, Kenya Revenue Authority to the owners of goods and and general public, that unless the goods specified and listed as found in the Kenya Revenue Authority website per the web links listed 1 & 2 below are lawfully entered and removed from the custody of the Customs Warehouse Keeper (INLAND CONTAINER DEPOT (ICD) NAIROBI) within thirty (30) days from the date of this notice, the said goods shall be deemed to have been abandoned to Customs and will be disposed in accordance with the provisions of EAC CMA 2004.
