7. Ni ryari umusoro ku nyungu umenyekanishwa?

Umusoro ku musaruro ubarwa mu gihe cy'umwaka usanzwe utangira ku itariki ya mbere Mutarama kugeza ku ya 31 Ukuboza ku bafite igihe cy'isoresha gisanzwe.

Icyakora, Minisitiri ashobora, iyo abisabwe mu nyandiko, kwemerera mu nyandiko usora gufata ikindi gihe cy'amezi cumi n'abiri (12) nk'igihe cye cy'umusoro iyo yujuje ibisabwa bikurikira:

1. Kuba ari ikigo cyishyura umusoro ku nyungu z'amasosiyete;
2. Kuba akora ibaruramari akurikije amahame y'ibaruramari yemewe;
3. Kuba agaragaza impamvu zifatika zo guhindurirwa igihe cy'umusoro.

9. Ni ikihe gipimo cy'umusoro ku nyungu z'amasosiyete?

1. Amasosiyete yishyura umusoro hashingiwe ku nyungu nyakuri, yishyura umusoro ku gipimo cya 28%; icyakora mu mwaka wa 2023 hazakoreshwa uburyo bw'ijanisha hagendewe ku gihe itegeko rishyiraho ijanisha rya 28% ryasohokeye mu igazeti ya Leta.

Ni ukuvuga ko kuva ku itariki 01/01/2023 kugeza ku itariki 13/09/2023 umusoro uzacibwa ku ijanisha rya 30% hanyuma kuva ku itariki 14/09/2024 kugeza ku itariki 31/12/2023 umusoro ukabarirwa ku ijanisha rya 28%
