**PUBLIC NOTICE**

**FINAL AMNESTY ON STORAGE CHARGES ON OVERSTAYED CARGO AT THE PORT OF MOMBASA**

Following the 11<sup>th</sup> Northern Corridor Integration Projects (NCIPS) Summit Directive to extend the waiver on storage, demurrage and Customs warehouse rent by 60 days to facilitate clearance of overstayed cargo at the port of Mombasa;

The stakeholders held a meeting on 27<sup>th</sup> January, 2016 to chat out and agree on the modalities for the implementation of 100% waiver. This meeting was attended by Ministry of Transport & Infrastructure (Republic of Kenya) and the implementing parties namely; Kenya ships Agents Association, the shipping lines, Kenya Ports Authority, Kenya Revenue Authority, Uganda Revenue Authority, Rwanda Revenue Authority and Kenya Maritime Authority.

All importers are hereby notified that all **storage charges, Demurrage Charges and Customs Warehouse Rent** accrued on long stay cargo discharged at the port of Mombasa on or before the 30<sup>th</sup> November, 2014 shall be waived in full.

The Cargo Must however be cleared and removed from the Port/Container freight stations within sixty( 60) calendar days with effect from **14<sup>th</sup> March 2016** up to **12<sup>th</sup> May 2016**.

Importers are therefore advised to take advantage of this final amnesty and clear their goods before the expiry period.

Dushyingiye ku byemezo by'i nama ya 11 y'abakuru b'ibihugu bigize umuhora wa ruguru (NCIPS) yategetse gusonera amafaranga y'ububiko bwo ku cyambu, ubwa Gasutamo ndetse n'amafaranga acibwa n'abakora imirimo y'ubwikorezi bwo mu mazi ku mizigo yatinze ku cyambu cya Mombasa.

Dukurikije imyanzuro y'inama yahuje abafatanyabikorwa barebwa n'iki kibazo yabaye ku itariki ya 27 Mutarama 2016, yigaga ku buryo aya ababwiriza yashyirwa mu bikorwa, inama yemeje ko:

1. Ubukode bwose bujyanye n'ububiko bwo ku cyambu busonewe;
2. Ubukode bwose bujyanye n'ububiko bwa Gasutamo busonewe;
3. Amafaranga acibwa n'abakora imirimo y'ubwikorezi bwo mu mazi asonewe.

Imizigo isonewe ubu bukode ni iyageze ku cyambu cya Mombasa mbere y'itariki ya 30 Ugushyungu 2014. Hakaba haratanzwe igihe cy'iminsi mirongo itandatu (60) uhereye kw'itariki ya 14 Werurwe 2016 kugeza ku ya 12 Gicurasi 2016.

Ubuyobozi bwa Gasutamo burakangurira abatuzuzwa mu mahanga baba bagifite ibicuruzwa byageze ku cyambu cya Mombasa mu gihe cyavuzwe haruguru ko bakwihutira kubimenyekanisha ku cyambu cya Mombasa.

Uwacyenera ibindi ibisobanuro birambuye yakwegera Ubuyobozi bwa Gasutamo i Gikondo Magerwa cyangwa ibiro bya Gasutamo ku cyambu cya Mombasa.
