Hashingiwe ku mpinduka abasora bamenyeshajwe zijyanye na gahunda ya EBM Kuri Bose nk'uko yashyizwe mu bikorwa kuva mu mwaka wa 2020 ndetse n'itangazo no. 1862/RRA/CG/EBM/2020 rimenyeshya abasora bose ko inyemezabuguzi zizemerwa gukurwa mu musaruro usoreshwa mu mwaka wa 2021 ari izizaba zaratanzwe hakoreshejwe EBM ku byaguzwe mu gihugu cyangwa n'imenyekanisha ryo muri Gasutamo kubyatumijwe mu mahanga cyangwa iry'umusoro ufatirwa;

Ubuyobozi bw'Ikigo cy'Imisoro n'Amahoro (RRA) buramenyeshya abacuruzi bose ko tugeze mu kwezi kwanyuma ko kumenyekanisha no kwishyura umusoro ku nyungu zabonetse mu mwaka wa 2021 bityo bugasaba abo bireba bose kumenyekanisha no kwishyura uyu umusoro hakiri kare kugira ngo ubufasha bwakenerwa kuri RRA, abajyanama mu by'imisoro cyangwa banki bakorana nazo butangwe mbere tudategereje itariki ntarengwa ari yo 31/03/2022.

RRA iramenyeshya kandi abasora bose ko hakoreshejwe ikoranabuhanga mu isesenguramakuru, sisitemu ihindura icyiciro usora abarizwamo (income tax regime) hashingiwe ku gicuruzo (turnover) agejejeho nk'uko itegeko No. 026/2019 rigena uburyo bw'isoresha ribiteganywa. Buri usora akaba asabwa kwihutira hakiri igihe kumenya ibiteganywa n'amategeko mu cyiciro agezemo kugirango ashobore gusora hakurikijwe amategeko.

Mukeneye kwihugura mu kumenyekanisha umusoro ku nyungu mwakwifashisha imfashanyigisho ziri ku rubuga rwa YouTube rwa RRA cyangwa mukaduhamagara kuri 3004.

ANNOUNCEMENT


Reference is made to the changes communicated to taxpayers which came a result of rolling out the EBM for All Program implemented since 2020.

Reference is also made to the announcement no. 1862/RRA/CG/EBM/2020 informing all taxpayers that expenses not supported by EBM Invoices for local purchases, customs declarations for imports and withholding tax declarations will not be accepted as deductible expenses during income tax declaration for the tax period of 2021;

The management of Rwanda Revenue Authority informs all businesses that we are in the last month for filing and paying Income Tax for the period of 2021 with the deadline set for 31/03/2022. It is in this regard that every concerned taxpayer is requested to file and pay this tax early enough to allow enough time to obtain support from RRA, Tax Advisors and their commercial banks in cases of need.

RRA also informs all taxpayers that with the use of data analytics, the system automatically changes taxpayers income tax regime based on the accrued turnover in accordance with provisions of law no. 026/2019 about tax procedures. Hence, every taxpayer is requested to check the provisions in their current tax regime in order to pay their tax following the law provisions.
