## DECLARATION AND PAYMENT OF TAXES AND FEES

### A) DECLARATION

#### USING MOBILE PHONE (M- DECLARATION)

- Dial **\*800#**
- Select language (**2**: English)
- Select:
  - 1: Motorvehicle taxes
  - 2: Other activities
  - 3: Decentralized taxes and fees
- Select:
  - 1: Registration
  - 2: Declaration
- Fill in the required information (Year,...)
- Approve the message from the system
- View the message indicating the amount of tax to pay and reference number.

#### USING INTERNET

- Login to RRA website: [www.rra.gov.rw](http://www.rra.gov.rw)
- Select **“Pay Domestic Taxes Here”**
- Enter your TIN and Password
- Choose the “tax type” you are making declaration
- Fill in the required information
- Submit
- Get acknowledgement
- Print/ send by Email or phone the acknowledgement
